CANCELLATION POLICY (YYC-DEL)

- Cancellations any time ticket is nonrefundable in case of cancel
- Waived for death of passenger or family member
- Ticket is nonrefundable in case of noshow
- Waived for death of passenger or family member
- Note ticket is nonrefundable and has no remaining value in case of noshow changes any time changes permitted
- Note ticket validity ticket is valid for 1 year from the original date of issuance and travel must commence within this validity period
- Once travel has commenced then all travel must be completed within 1 year from the date on which travel commenced
