## Important Notices / Special Requests\*

Effective 01APR21, the state of Quintana Roo, which includes Cancun and Cozumel, will be requiring all international travellers over the age of 14 to pay a tourism usage fee of 244.00 Mexican pesos, approximately 15 CAD depending on the current exchange rate. The payment can be made prior to travel, upon arrival or during the stay, as the tax will be imposed upon departure. Travellers have the option to access <http://visitax.gob.mx/>, where they can complete a brief questionnaire and make the payment in advance of or during their visit. A receipt will be provided which must be shown at the airport prior to boarding their flight home. Due to COVID-19, components of your vacation such as flight, hotel amenities services, excursions, ground transport etc. which are provided by third-party suppliers may be different than advertised, including being reduced or unavailable. While Sunwing will take reasonable measures to ensure that all components of your vacation are as advertised at the time of sale, by booking, you understand and accept that Sunwing cannot be held liable for such changes. If Sunwing becomes aware of such changes in advance, it shall, in certain situations, promptly provide notification to you and offer a refund or comparable alternate travel services acceptable to you. As announced by the Government of Canada, effective November 30, 2021 all air passengers 12 years of age and older departing from Canadian airports must be fully vaccinated to travel, with limited exceptions. Air passengers are required to provide proof of full vaccination from federally accepted vaccines taken no less than 14 days before travel. Limited exceptions will be granted for medical or religious reasons, and air passengers will be required to provide additional documentation to be considered exempt. Those who are exempt will be required to provide proof of a negative COVID-19 molecular test result taken 72 hours before the scheduled flight departure. Also, passengers must complete a declaration confirming they meet the requirements for travel and must be prepared to show proof of either requirement upon request prior to boarding. Failure to comply will result in denied boarding and may result in a fine up to 5,000 per violation under the Aeronautics Act. As travel requirements are changing rapidly, it is the traveller's responsibility to check the entry requirements of the country they the entry requirements into Canada. For travel up to and including March 31, 2022 all travellers 5 years age and older must provide proof of a valid COVID-19 molecular test result prior to boarding a flight to Canada. Negative molecular test results must be taken within 72 hours prior to departure. Previously positive molecular tests must have been administered within 10-180 days prior to departure to be acceptable. Travellers 5 years and older also have the option to demonstrate proof of a negative Rapid Antigen Test (RAT) as an alternative to a molecular test (e.g. a PCR test). Antigen tests will need to be taken a day prior to the scheduled flight departure and must be administered by a laboratory, healthcare entity or telehealth service provider. Beginning April 1st, fully vaccinated travellers five years of age and older will no longer be required to provide proof of a negative COVID-19 molecular test or Rapid Antigen Test (RAT) before travel to Canada. Travellers entering Canada must submit all relevant information on the ArriveCAN app, or online at [Canada.ca ArriveCAN](https://www.canada.ca/arrivecan) including contact details, travel history and proof of vaccination.
