- Cancellations any time ticket is nonrefundable
- · Waived for death of passenger or family member
- Note text below not validated for autopricing
- Waivers must be evidenced by death certificate
- Refund permitted before departure in case of rejection of visa
- Embassy statement required
- Refund rules apply per pricing unit
- When combining nonrefundable fares with refundable fares 1. the most restrictive cancellation condition applies to the entire pricing unit
- 2. the highest cancellation penalty within the pricing unit will be charged

- Refund for partly used ticketif a return ticket shall be used for one way travelthe difference between the return fare and the applicable
  one way fare will/shall be calculated
- Applicable one way is the one way fare within the same or higher rbd

- When changes are made and the originally ticketed booking class is kept the new fare may be lower/equal or higher
