Secure Flight Program:

TSA (Transportation Security Administration) requires passengers to provide airlines with their date of birth and gender. Failure to do so or providing the incorrect data may result in additional screening, increased check-in time, denial of boarding and/or booking cancellation. To comply with TSA Secure Flight requirements, we require all passengers date of birth and gender AT TIME OF BOOKING. For existing booking without secure ight data, date of birth and gender are required no later then 72 hours prior to departure.

Passport and Visa:

Make sure your passengers have all the necessary documents (passport and/or visa) for all stopovers, transfers and destinations included in their itinerary.

Registration of Canadians abroad

The Foreign Affaires and International Trade Canada offers a registration service for all Canadians travelling or living abroad. This service is provided so that we can contact and assist you in an emergency in a foreign country, such as a natural disaster or civil unrest, or inform you of a family emergency at home.
