Guidelines For customers from India to Thailand

1Requirements for Fully Vaccinated Customers

2Child Above 5 year :- RT-PCR test Report UNDER 48 HRS mandatory for International Travel it should be With QR code and report should be from ICMR LAB REPORT WITH IN 48 HRS

For all customers travelling to Thailand above 18 years of age are required to be fully vaccinated with WHO approved vaccines and should have completed at least 14 days from the receipt of the 2nddose of the vaccine

The vaccination certificate presented must be in English or Thai only. It should indicate passenger Identification (ID) including passenger name, passport number or Date of birth and name of the vaccine and date of vaccination.

For those between 5-17yrs need single dose of vaccine of two dose regime and last dose taken at least 14 days before departure

Fully vaccinated customers are exempted from both pre and post Covid-19 Test for Thailand

Requirements for Partially or Unvaccinated Customers

3All customers are required to be in possession of RT PCR/ Professional ATK test report (self ATK not permitted) issued within 48hrs before travelling to Thailand

Special Circumstances

Children below 5yrs are exempt from Covid-19 testing requirements but must travel with parents or guardians.

Children under 18 years of age can travel alone as an unaccompanied minor if the child has received one dose of vaccination or holds a negative RT – PCR or Pro – ATK test results issued within 72hrs before departure.

Children below 18yrs old who are travelling with fully vaccinated parents are exempt from vaccine or Covid – 19 testing requirements.

Recovered Customers

For passengers with COVID-19 recovery between 14 - 90 days after the first date of symptom or first date of the positive test, no vaccination is needed.

If a passenger holds a Covid-19 recovery certificate, which lasts longer than 90 days, a single dose of vaccine will be accepted as being fully vaccinated.

Child RTPCR test is Mandatory air suvidha :- RT-PCR test Report UNDER 48 HRS mandatory from Foreign Airport to other Indian States it should be With QR code and report should be from ICMR LAB REPORT WITH IN 48 HRS

3All customers including children and infants shall be mandatorily required to submit self-health declaration form on (<https://www.newdelhairport.in/airsuvidha/apho-registration>)Air Suvidha Portal (<https://www.newdelhairport.in/airsuvidha/apho-registration>)

India along with its own vaccination certificate, recognizes vaccination certificate of 108 countries on reciprocity basis. Customers in possession of final vaccination certificate from these 108 countries shall no longer be required to upload pre-departure RT-PCR negative report on Air Suvidha Portal. However they shall be required to upload the final vaccination certificate**

5Upon arrival into India;

There shall be no requirement of any type of quarantine however customers shall be required to self monitor their health for 14 days

2% of the customers shall be randomly tested at their own cost and shall be allowed to leave the airport upon sample collection

6If tested positive they shall be informed and treated/isolated as per laid down protocol

7Children under the age of 5 years shall be exempted from pre-departure and post arrival covid testing

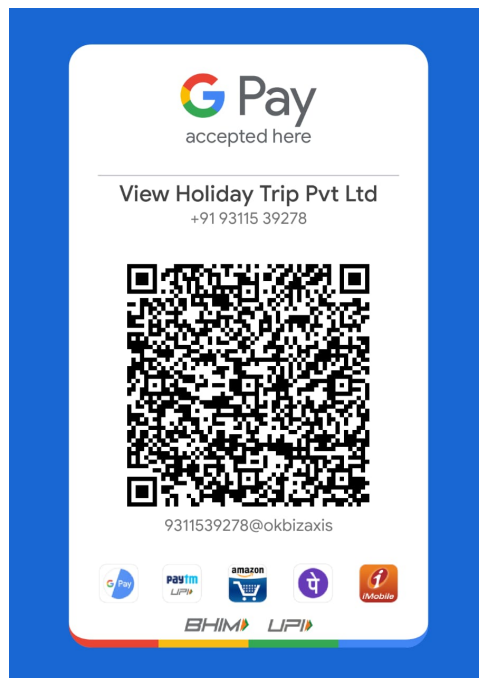
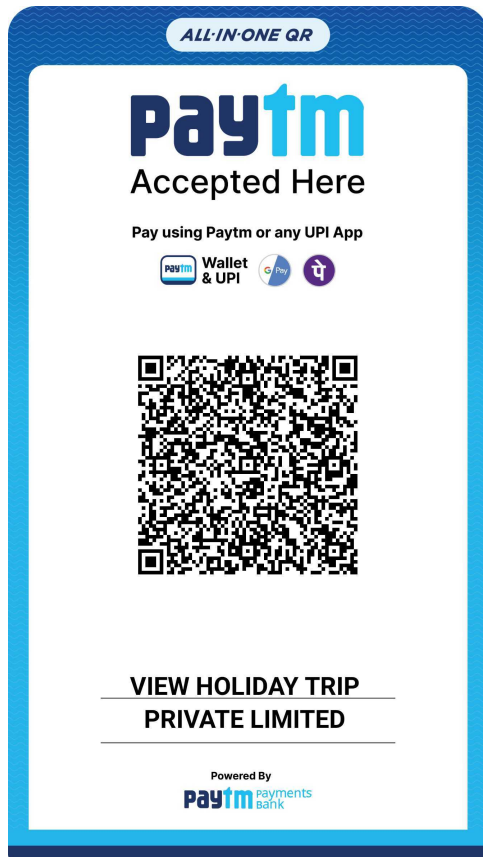
